
TERMS AND CONDITIONS

BACKGROUND:

This agreement applies as between you, the User of this Web Site and Stampiton Labels Limited, the owners of this Web Site. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of the Web Site. If you do not agree to be bound by these Terms and Conditions, you should stop using the Web Site immediately.

Your order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to you indicating that your order has been fulfilled and is on its way to you.

1. Definitions and Interpretation

“User” / “Users”	means any third party that accesses the Web Site and is not employed by Stampiton Labels Limited and acting in the course of their employment; and
